ANNUAL RESIDENCY VERIFICATION ENHANCEMENT

March 2023

District 214 has moved to an annual residency verification process for parents. Verifying residency protects taxpayers and district resources by identifying non-residents attending District 214 schools.

The District is contracting with a third-party vendor to verify student address data. The vendor will use a parent's name and address for crosschecking the information against other public electronic databases, such as utility companies. It is expected that most families will have their residency verified electronically.

Once verified, each household will receive an emailed confirmation, and there will be no need to submit additional paperwork certifying residency within the district's boundaries.

Communication will be sent to families whose residency cannot be verified electronically. Details will be provided on the documentation needed to complete registration and verify residency for the upcoming school year.

Please contact your Associate Principal of Operations with any questions or concerns regarding this streamlined process for our parents.

Township High School District 214 Registration In C. 2023-24

Welcome to the 2023-24 school year. The first full day of classes will be **Wednesday**, **August 16**, **2023**.

Township High School District 214 uses an On-Line Registration and Fee Payment Process. You may complete your registration at home or any location with Internet access. Please plan to allow at least 30 minutes to complete the registration. On-Line Registration will begin Monday, June 5, 2023, at 8:00 am central time. Please go to your home school website - Infinite Campus link. On-Line Payments will be accepted using a credit or debit card (MasterCard, Discover, or Visa). You will need the Student's ID number, student's home school name, zip code, and birth date to log in. Please follow the directions on the website and verify that demographic information, especially your email address, is current and up to date. If you do not have access to a computer or prefer to pay using cash, check, or money order, please go to your home school's main office to complete the registration process.

Due to the global COVID-19 pandemic and the economic burden on many families, the Board of Education has voted to waive the 2023-24 registration fee for all students. Co-curricular fees will also be waived. Seniors have an additional fee of \$40.

Students on a fee waiver will have the remaining applicable fees waived.

Any optional fees (not included online), health and immunization records, athletic registrations, and other information in this packet must be mailed in or dropped off in the main office.

Transportation is **free** for students beyond 1.5 miles from school, and sign-up is unnecessary. Students not eligible for free transportation may purchase this service (\$675 for the 2023-24 school year) based on seat availability on regular routes. Please contact the main office for more information.

If you are applying for a fee waiver, use the Meal Benefits Application in the Infinite Campus Parent Portal under the More Tab-Meal Benefits.

Reminder to all Freshmen and New Students: You must provide an original birth certificate, and residency must be verified. In addition to On-Line Registration, a current physical and the appropriate immunization records are required for your enrollment to be complete. You can download and print these medical-related forms from the registration website.

Returning Students: After July 29th, schedules, IDs, bus schedules, and other information will be available once online registration is complete and outstanding obligations have been cleared.

Students attending Alternative Schools or Programs Outside the District must register, pay fees, and apply for fee waivers at their respective **home school main office**. It is imperative that all students, regardless of where they attend school, register at their home school. Failure to register within the appropriate timelines will suspend all services, including transportation.

Student Accident Insurance enrollment forms for coverage through 1st Agency Insurance Company are available in the Main Office or on the registration portal website. If you elect this additional coverage for your student, follow the instructions outlined in the brochure. 1st Agency Insurance Company is not affiliated with Township High School District 214.

DISTRITO DE ESCUELAS SECUNDARIAS 214 INFORMACIÓN PARA LA INSCRIPCIÓN DEL AÑO ESCOLAR 2023-24

Bienvenido al año escolar 2023-24. El primer día de clases es el miércoles 16 de agosto, 2023.

El Distrito de Escuelas Secundarias 214 usa Internet para el proceso de inscripción. Usted puede completar el proceso de inscripción desde su casa o cualquier lugar que tenga acceso a Internet; Por favor, vaya al sitio web de su escuela en casa. Por favor haga planes para permitir al menos 30 minutos para completar el registro.

El primer día de inscripción es el 5 de junio, 2023, 8:00 am hora central. El único método de pago que se acepta usando Internet es una tarjeta de crédito (Visa, MasterCard o Discover). Para iniciar la sesión necesita el número de identificación de su estudiante, nombre de la escuela secundaria, código postal, y fecha de nacimiento. Por favor siga las instrucciones en la página web y verifique que toda la información está correcta, especialmente su correo electrónico. Debido a la pandemia global y la carga económica de COVID-19 que recaen sobre muchas familias, la Junta de Educación ha votado para no aplicar la cuota de inscripción 2023-24 para todos los estudiantes. También se eliminarán las tarifas co-curriculares. Las personas mayores tienen una tarifa adicional de \$40.

Township High School District 214 Freshman Registration, Residency & Birth Certificate Verification 2023-24

Welcome to Township High School District 214! We look forward to your student joining the District 214 schools as a high school freshman. The first full day of classes will be **Wednesday**, **August 16**, **2023**.

As part of the registration process, parents/guardians of freshman students are required to present an original birth certificate. Residency must also be verified using a more efficient electronic verification process, which you may have already received information on.

If residency cannot be verified electronically, you will be notified by your child's school and need to provide the documentation listed below:

Category A (At least <u>ONE</u> of the following documents):

- Most recent mortgage bill/statement
- Most recent real estate tax bill
- Closing statement for the purchase of residence
- Deed/closing document to real estate
- Signed apartment lease for my residence from owner/lessee

AND

Category B (At least TWO of the following items):

- Driver's license with current address
- Current utility bill (gas, water, electric or cable)
- Public Aid card
- Voter registration card
- Automobile registration State of Illinois
- Receipt for city vehicle sticker

OR

Category C If <u>NONE</u> of the items in Categories A or B are applicable, you will need to contact the main office at your school.

An Original Birth Certificate, Passport, or Visa is required to be presented.

Township High School District 214 uses an Online Registration and Fee Payment Process. Once residency verification is complete, you can complete your registration at home or any location with Internet access. Kiosks will be set up in your child's school to assist you.



We look forward to your student joining the District 214 schools for the first full day of classes **Wednesday**, **August 16**, **2023**. As you know, District 214 utilized an electronic residency verification process for students. As described in Board Policy, students who attend our schools must reside within the district's boundaries. Verifying residency annually helps us to protect district taxpayers by ensuring that resources are spent only on students who live within the D214 community.

You are receiving this message to inform you that your residency within District 214's boundaries, unfortunately, could not be verified electronically. As a result, you are required to provide documentation to verify that you are a resident within your school's boundaries before your child can register for or attend school next school year. Below is a list of the necessary documents that must be provided. In order for your child to attend school next year, you must verify your residency prior to July 14, 2023.

Category A (At least <u>ONE</u> of the following documents):

- Most recent mortgage bill/statement
- Most recent real estate tax bill
- Closing statement for the purchase of residence
- Deed/closing document to real estate
- Signed apartment lease for my residence from owner/lessee

Category B (At least <u>TWO</u> of the following items):





HOW IT WORKS

The criteria for the Harper College Promise Scholarship were developed by Harper College, area public high schools and northwest suburban business leaders to promote life skills and habits that will help students succeed in college and provide businesses with smart, skilled and motivated employees. The Promise Scholarship Program enables participating students to attend Harper without having to pay tuition while they earn career certifications and associate degrees. However, signing up for the Promise program does not commit a student to go to Harper. So there's no reason not to sign up!

IN HIGH SCHOOL

The Program starts in the second semester of a student's freshman year in high school. If the student meets attendance, rigor, quality, persistence and community service requirements, the student can earn up to two years tuition at Harper College.

Dear Parents,

- Sudden Cardiac Arrest (SCA) is the leading cause of death in the U.S., claiming the lives of 1,000 people every day. SCA is the #1 killer of student athletes, the leading cause of death on school campuses and the #2 medical cause of death in young adults under the age of 25. In fact, 1 in 300 young adults have an undetected heart condition that puts them at risk.
- SCA is often confused with a heart attack but the 2 conditions are very different. A heart attack happens when blood flow to the heart is blocked. During a heart attack, the heart usually doesn't suddenly stop beating where with SCA, the heart abruptly stops beating.
- SCA typically results in death, nearly 90% of SCA victims do not survive.
- The normal rhythm of the heart can only be restored with defibrillation, an electrical shock that is safely delivered to the chest by an automated external defibrillator (AED) and many time this help is not available in time.
- In 2005, Max Schewitz died without warning from a hidden heart condition at 20 years of age. HeartSmart EKG helps find at-risk young adults so they can seek treatment and not share Max's fate.
- EKG's are not routinely done on seemingly healthy young adults in our communities. **A painless, simple and non-invasive EKG detects 94% of high-risk individuals** compared to 20% detected by a physician discussing family history or 9% by physical examination. We think it's worth looking for these kids!
- HeartSmart EKG has tested over 100,000 young adults and referred over 1,000 individuals for additional testing. Sadly, our HeartSmart EKG program will be winding down and our last cardiac testing will be in November of 2023. This will be your last chance to have your student tested at Elk Grove High School by HeartSmart EKG.

Screening will be offered on Wednesday, March 15th to all Elk Grove High School Students.

- Testing includes an EKG for all participants in a 15-minute appointment selected by parents after registration.
- Students selected by the cardiologist will also receive an echocardiogram within 1 week of the screening for no additional cost.
- Only students with permission, which is granted through the online registration process, will be tested.
- Because the heart changes over time, even previously tested students should register for testing.
- Testing costs are \$20 per student if registered by Tuesday, March 7th and will increase to \$25 per student if registered after 3/7/23. Thanks to underwriting provided by District 214, the HeartSmart EKG program will be offered to students on the free and reduced lunch program at no cost.
- Payment is required at time of registration and no refunds will be issued. If your student is not tested, your registration fee will be considered a donation to save other students.

- Every effort is made to respect privacy and modesty. Testing takes place in private booths in the Alternate Gym. Males and females are tested separately and students do not remove their shirt for EKG testing.
- Cardiologist Eli Lavie, M.D. oversees all aspects of testing and interpretation.
- Due to COVID-19, we have implemented protocols for the safety of our staff and students. The Max Schewitz Foundation staff has been fully vaccinated and will be handling testing of all students.
- Results are confidential and are shared only with parents within 2 weeks after testing through HeartSmart EKG's online portal. Included in the results will be a copy of the EKG.

The District also maintains compliance with the Illinois Department of Public Health (IDPH) and Cook County Department of Public Health (CCDPH) guidelines for operations and maintenance activities. The District routinely performs operations and maintenance activities, required inspections, and surveillance activities to verify that the materials are being managed according to IDPH and CCDPH guidelines.

The Building and Grounds Department of each individual facility and the District Operations Department have copies of the AHERA Management Plans that describe the locations of all ACBM. These plans are available for inspection during regular business hours. Contact the Director of Operations for more information at 847-718-7619.

<u>PESTICIDE APPLICATION NOTIFICATION REGISTRY:</u>

All District 214 facilities practice Integrated Pest Management to minimize the use of any pesticides on school grounds. The Structural Pest Control Act (225 ILCS 235/) and the Lawn Care Products Application and Notice Act (415 ILCS 65/) requires public schools to notify parents/guardians and school employees at least 48 hours (two business days) prior to any pesticide applications on school grounds. The term "pesticide" includes insecticides, herbicides, rodenticides, and fungicides. The notification requirement extends to both indoor and outdoor pesticide applications. Excluded from the notification requirement are antimicrobials such as disinfectants, sanitizers or deodorizers, insecticide baits and rodenticide baits.



Dear Parent/Guardian,

Immunization Requirement for the 2023-2024 School Year:

For the 2023-2024 school year, <u>all students entering 12th grade shall show proof of having received two doses of MENINGOCOCCAL CONJUGATE VACCINE (Menactra, Menveo, MCV4) prior to starting school.</u> The first dose should have been administered on or after their 11th birthday and the second dose on or after their 16th birthday. An interval of at least eight weeks between the first and second dose is required. Only one dose of the vaccine is required if the first dose is administered when the child is 16 years of age or older. You do not have to wait until your child is going into 12th grade to get the 2nd dose of meningococcal conjugate vaccine - once your child turns 16 years-old they are eligible to receive it.

Your child may have already received both doses of the required Meningococcal Conjugate Vaccine, however we may not have received proof that they were given. Please check with your child's medical provider to determine if they received the two Meningococcal Conjugate Vaccines and, if they were given, please ask that they complete all information indicated below, including their signature and office stamp. If your child has not received both doses, you are required to get this vaccination for your child or your child will be subject to exclusion as described in the school code of Illinois.

Your child will not be able to receive their class schedule or attend school in August until all immunizations are up to date.

Please submit this completed form or an updated immunization record to the Health Office at Elk Grove High School as soon as possible.

Meningitis Vaccine Requirements:



Please note - all students 16 years of age and older are required to receive a meningococcal vaccine prior to entering 12th grade. If the school health office does not receive proof that your child received the required meningococcal vaccine by the first day of school for the 2022/23 school year, your child can be excluded from school until the appropriate documentation is received by our school health office. Students who have a medical, or other reason, for not receiving the vaccine must provide documentation to the health

office indicating the exception.

Chronic Health Conditions:

School achievement is dependent upon effectively meeting the health needs of each student. If your student has a chronic health condition such as asthma, severe allergies, diabetes, or a seizure disorder, it is important for the school, medical provider, and family to work together to provide the best educational experience possible.



In an effort to provide your student the opportunity for a successful school year, a number of printable healthcare

plans are available on the Elk Grove High School website under the Health Services tab: https://www.d214.org/Page/265. Care plans are designed to help the school nurse collaborate with your student's medical provider and family to ensure that the child's healthcare needs are met at school. You can print the care plan from the link listed above or contact the school health office to receive a care plan by mail or via email. A new/updated care plan must be completed and turned in at the beginning of each school year, or as soon as possible after the school year begins.

Students Needing Medication at School:



If your student requires daily or "as needed" medication at school, or if they require an epinephrine injector or inhaler to self-carry or keep in the health office during the school year, we ask that the district medication permission form be completed for each medication needed. This form is located on the Elk Grove H.S. website under Health Services: https://www.d214.org/Page/265. Please sign and date the form and have your child's medical provider complete the section indicated. The form

should then be turned into the school health office along with the medication. All medications provided to the school health office must be in their original container or packaging, or alternatively, the medication must be in an appropriately labeled container from a pharmacy.

Students with Asthma:

Illinois State Law requires that all students diagnosed with Asthma have an <u>Asthma Action Plan</u> on file with their school. An <u>Asthma Action Plan</u> is a plan developed by you and your child's medical provider that provides the school nurse with an individualized plan of care for your student in the event that they experience asthma symptoms at school or at school-sponsored events (such as coughing, wheezing, shortness of breath, chest tightness or difficulty breathing). We encourage you to consult with your child's



medical provider whether or not the child can self-carry their emergency asthma medication at school or if you prefer to keep it with the school nurse. The <u>Medication Permission/Medication Self-Carry Form</u> must be completed and turned in along with the <u>Asthma Action Plan</u>. The links to all of the appropriate forms are listed below. We ask that you print out the forms you need, sign/date them, and have your student's medical provider complete their portion of the form. The completed forms should be returned to the School Nurse at your student's school.

Strategies to Support Our Students


Introducing Gold Card shoutouts for students! This initiative focuses on student recognition and improving students performance or engagement within the classroom, as well as building student teacher connections.
